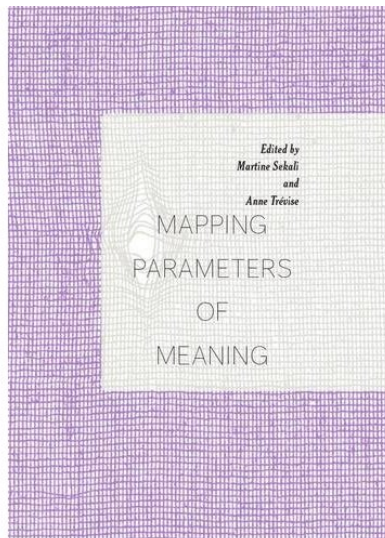

The book contains a selection of papers presented at the conference *Mapping Parameters of Meaning*, an event organized by the GReG linguistics research group (CREA) at the Language Department of the University of Paris Ouest Nanterre on November 19-20, 2010. The volume addresses the description of meaning construction processes, and the necessity for new linguistic interface-tools to analyze it in its dynamic and multi-dimensional aspect. Syntax, grammar, prosody, discourse organization, subjective and situational filters are not considered as autonomous systems; on the contrary, they are shown to systematically converge in the process of meaning construction and interpretation.

The book is of value to anyone interested in the interaction between syntax, semantics and pragmatics in the gradual construction and interpretation of meaning in natural languages, including researchers, students and scholars of formal linguistics, cognitive linguistics and discourse analysis.
